



Terms of Use – Elk Island Catholic RSD 41 - PowerSchool Public Portal

Description of Service

Elk Island Catholic Schools (“EICS”) provides the PowerSchool interactive portal as a way for parents to interact with the school and perform tasks such as:

- Viewing Academic Performance for their children within the division
- View attendance information for their children within the division
- View and pay school fees for their children within the division
- Other features as added

Use of the portal and these features is subject to the following terms and conditions:

Terms of Access

Accounts: Users of the portal (both students and parents) are issued or given the ability to create a unique account. Access within the portal is granted to these unique accounts. Providing complete and accurate information when creating this account and the subsequent protection of the username and password for these accounts is the responsibility of the end user.

Collection, Presentation and Use of Personal Data

Visibility to Students: Access to this website is granted based upon the relationship of the user to one or more students within the district. Access for a specific user may be changed or terminated as a result of:

- a. Violation of the terms of use by that user
- b. A court order or protection order requiring the removal of access
- c. That user no longer being related to one or more students within the district
- d. A decision made by EICS staff to modify the features available on the PowerSchool Public Portal

Presentation of Data: Data presented to users of this portal is displayed in confidence to the end user, based upon the fact that they have a demonstrated current relationship to the student and have been charged with maintaining the security of their account credentials. It is the responsibility of the end user to:

- a. Notify EICS in the event that you find information in the Public Portal which you should not be privy to
- b. Not reproduce or redistribute materials from this portal except for personal, non-commercial use
- c. Use the information and materials provided on this portal solely for lawful purposes
- d. Recognize that there is no guarantee that the information and materials offered on this portal are complete, accurate and free of errors and that we expressly exclude liability for any inaccuracies or errors
- e. Acknowledge that in the event of an unauthorized use of this portal, or the information and materials contained within, EICS shall be entitled to all remedies available at law or in equity

Collection of Data: All data collected is subject to the FOIPP Act and is handled in accordance with our Privacy Statement.

Data is collected for several purposes including but not limited to the following:

- a. IP Address – as part of our internet security the IP address of a computer logging into the Public Portal is logged
- b. User Credentials – as part of the account creation process users are asked to enter information to be used as their user credentials
- c. Email Address – as part of the account creation process users are asked to enter an email address
- d. Payment information – as part of the fee payment process users are asked to enter payment information
- e. Student Record Portfolio information – some areas of the portal may permit users to view or submit updates to contact information and other demographic information available on the student record

EICS works with a number of third party technology providers to deliver services such as attendance notification messages and online fee payment services. Information is provided to these third party technology providers solely to facilitate delivery of those services and remains protected under the FOIPP Act.

All personal information is managed according to the FOIPP Act.
